Milton's Blind Language (manuscript nearing completion)

A study on the workings of blindness towards the making of John Milton's poetic language in his years of gradual and final loss of sight; the poetry examined includes Milton's psalm translations in his years of going blind, his later sonnets, and his last long poetry, *Paradise Lost, Paradise Regained*, and *Samson Agonistes*.

## PLANNED BOOK PROJECTS

Crossings of Disability, Race, and Empire in the Early Modern World (work in progress)

A study of the cultural productions of disability and the intertwined phenomena of global contact, race-making, and identity-making in the early modern world; primary sources for this work include canonical and marginal plays, remarkable and unremarkable poetry, accounts of actual and second-hand travel, broadside ballads, manuscript records of visual affliction and proposed remedies, printed and manuscript medicinal and culinary recipes, and religious and social tracts and sermons.

A Social History of Indian Mountaineering (work in progress)

An accessible account of Indian mountaineering, particularly Himalayan mountaineering, from its colonial "Golden Age" in the mid-twentieth century to the emerging models of the twenty-first; the investment of this work is in claiming space for mountaineers of the "non-traditional" kind—such as individuals at the intersections of less privileged genders, castes, social standing, financial reach, geography, and age—who have historically enlarged the scope of the sport but remain the least credited for this work.
